### **CIRCULAR 5 OF ASA 2022 - AFFILIATION OF TECHNICAL OFFICIALS**

Kindly note that Affiliation of ASA Technical Officials (TO's) is done for a two year period. The next affiliation period will be for 2022/2023.

All ASA Technical Officials must affiliate in their domicile province and the provincial office must keep a register of all affiliated TO's in the province and forward it to the ASA office.

#### **Affiliation Fee:**

Provinces can decide on the affiliation fee for TO's for the two year period. For uniformity during meetings it is recommended that provinces supply their TO's with a golf shirt. If the province is not in a position to sponsor these golf shirts (or part of it), the affiliation fee must include the price of the golf shirt and the accreditation card.

Affiliation fee for WA qualified TO's is **R400** and it must be payable to ASA **by the province**. ASA will supply these TO's with a golf shirt and an accreditation card. If the province would like to supply these WA TO's with a provincial shirt as well, it must be included in the provincial affiliation fee.

#### **Affiliation Form:**

The attached affiliation form must be used for all TO's. Provinces must capture the information on the attached ASA EXCEL form and the form with the information of all TO's must be forwarded to the ASA office with proof of payment of the ASA affiliation fee. Affiliation is due by **28 February 2022** and the summary form must be forwarded to ASA by no later than **11 March 2022**. Please mark all changes from the previous submission clearly.

#### **Licensing of Technical Officials:**

According to ASA Rule 15, an Eligible Technical Official is someone who:

- 15.1.2 is affiliated to a club registered with the domicile ASA Province;
- 15.1.3 is in possession of an ASA Permanent License;

All ASA TO's must therefore join a club in the domicile province and be in possession of a permanent ASA License, renewed every year. According to ASA Rule 25.4.1, Permanent Licenses are issued by ASA through the Provincial members to club members. Athletes (and Technical Officials) can only purchase a permanent license through a local athletics club.
